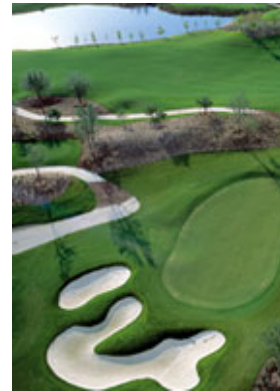

## RAW MILK

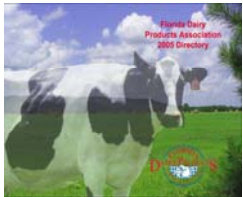
Legislation allowing for the sale of raw milk for human consumption was introduced by Representative Dwight Stansel, (D) Live Oak, in the 2006 Florida Legislature. The legislation would have allowed farmers and processors to package and sell unpasteurized milk for human consumption. The legislation outlined the sanitary requirements for "retail" sale; including, sampling, testing, cow health requirements, inspection and packaging. It required that all testing be done by a private laboratory. However, the legislation exempted farms that produced less than 50 gallons per week. It further provided that a consumer made sick by consumption of raw milk could not bring legal action against the producer-packager. Similar legislation was introduced in the Senate but was withdrawn. HB 1215 received four committee assignments and opponents have been assured that it will never get out of committee. FDPA has opposed this legislation along with Southeast Milk, Dairy Farmers Inc, Florida Farm Bureau, and Division of Dairy Industry.

## MILK CASE DEPOSITS

A discussion regarding the cost of lost (non-returned) milk cases took place at the December 2006 Board of Directors Meeting. Dr. Robert Degner, Attorney George Clapham and President Boosinger were asked to survey other states to determine if there might be existing legislation that required deposits on milk cases when delivered. FDPA contacted 27 states about case deposit legislation. Only New York had a law requiring case deposits. New York law required:

- 1) Name of case owner on case.
- 2) A deposit by wholesaler or retailer receiving the case (\$0.50 in New York City, \$2.00 upstate New York).
- 3) That the milk case deliverer access or collect the deposit (deliveries minus returns = assessment).
- 4) That proper records be maintained.

The New York case deposit is enforced by New York Division of Milk Control which is a "pricing" agency similar to a State Milk Commission.
